 draft application and get with Chief Tillery on what they think would work best for the city, and
 seconded by Vice-Mayor Nunley. All Commissioners voted yes. Motion carries.
- 2. Recognition of WHS Fishing Team students Westin Moss and Nathan Powell- The Commissioners recognized these two students with the help of our surrounding cities with a scholarship of \$725.00 a piece for the compassion they showed to another student fisherman's family. The Tennessee High School BASS Nation also recognized the City of Whitwell for their support.
